## Cycle to School Contract

Cycling to school can be a great, healthy way of travelling to and from school but, it can have its dangers too. To help ensure all children are safe when riding, we are introducing a 'Cycle to School Contract'. Parents/guardians and riders must read, understand and agree to the guidelines listed below. ALL children travelling to and from school on a bike, unaccompanied, MUST sign and return the form prior to them riding to school. Thank you for your understanding and co-operation.

### Riders Guidelines

- Any dangerous or inconsiderate behaviour will mean that my permission to cycle to school is withdrawn.
- I will wear suitable safety aids and a correctly fitting, approved cycle helmet.
- I will push my bicycle when I am inside school grounds.
- When crossing roads on my bicycle, I will dismount and push my bicycle. Riding across the road is dangerous.
- I will not interfere with any other bicycle in the school.
- I will use effective, working lights when appropriate.
- I will park my bicycle in the bicycle shed at the front of the school.

### Parent / Guardian Guidelines

- I take full responsibility for my child's bicycle and will ensure that it is roadworthy.
- School will not take any responsibility for the safety of my child, whilst on their journey to or from school, or their bike at any time.
- My child's bike will be parked in the bicycle shed at the front of the school and left at the owner's risk.
- I will ensure that my child's bicycle will be pushed when inside school grounds.
- I understand that the safety of my child during the journey to school is my responsibility and will ensure they are using safe routes if travelling by themselves.
- I will encourage the use of reflective materials and or a high visibility jacket or tabard.
- I have read, understood and accept the contract for the issue of a 'Cycle to School Contract'. I give permission for my child to cycle to school according to those rules.
- I understand that if the contract is broken, that permission to cycle to school may be withdrawn.
